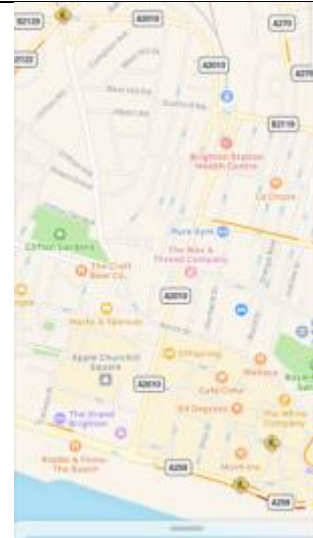
THE CONFERENCE WILL BE CHAIRED BY THE HONOURABLE MRS JUSTICE THEIS, DBE.
